Ok, guys, so here is the information on the new AP exam. Buckle up, there is going to be A LOT headed your way.

When: May 20, 2020 at 11:00 a.m. Plan on logging in at 10:30 a.m. to get set up. This is your exam day, you will not be granted an extension

Time Restriction: 45 minutes plus 5 minutes to upload.

Format:

- You have 2 choices on how to complete the exam: You can type it directly into the AP test or write it out on a piece of paper and upload a picture. Both of these must be done in the 45 minute window.
- Failure to hit submit after 45 minutes will result in no score this means even if you are done, if you fail to hit the button, it was all for nothing
- This will be open note/open book. That means you can use things given in class but you cannot use any outside help.

Plagiarism (from AP): IF YOU READ NOTHING ELSE, READ THIS PART, THEN READ IT AGAIN:

- Students who information mirrors that of online content or another student's submission will have their score immediately cancelled.
- Students sharing or receiving exam content or responses, or engaging in any plans or efforts to provide or gain an unfair advantage, will be blocked from testing or their scores will be cancelled this includes communications or assistance in-person, via the Internet, social media or any other means.
- If we determine that a student gained or provided an unfair advantage on an AP Exam, we'll notify their high school so the school can choose to take action, as appropriate (note: this is being discussed, and Damien will automatically give a failing grade to the student in that class at minimum). We will also provide information about the incident to any College Board scores (including SAT scores) or to which the student would send future scores (this is important! It means your cheating will be told to colleges!)
